- Diagnostic products and equipment
- Food and nutritional supplements
- Personal hygiene items

Accepted Items

- ❖ Items with 8+ month dating left prior to expiration
- ❖ Discontinued product
- ❖ Surplus products acquired in the consolidation of business operations
- ❖ Products with outmoded package design
- ❖ Excess products resulting from over-production (bulk or finished packaging)
- ❖ Other products that may not be utilized by the manufacturer, but does meet FDA standards and approvals
- ❖ Wholesaler returns

Unaccepted Items

- ❖ Expired products
- ❖ Any items(s) which does not meet FDA standards and approvals
- ❖ Any item(s) which do not meet sterility standards
- ❖ Product samples from physicians
- ❖ Medicines from individuals
- ❖ Used product
